Regarding: Application for Community Development Block Grant (CDBG) Funding for Griggs and Lexington Intersection Improvement Project (Resurfacing, ADA Compliant Sidewalks and stormwater)

Dear Commissioners:

For the 2017 CDBG Application, the Village of Ashville will be submitting two (2) project. This will be our Priority Two (2) Project. It will involve the resurfacing the roadway, installing ADA approved sidewalks and improving water drainage at the intersection of Griggs Street and Lexington Avenue as far west as Jefferson Avenue. This project will connect islands of sidewalks within the Village. It will also add to our program to link these islands of sidewalks and trails within the Village, see application exhibits.

The Percentage of LMI Persons is 60.0 to 100.0%. That information is in the Exhibits for the CDBG Application.

The funds that would be used by the Village of Ashville are General Fund Street Department Contractual 1000-670-399-0000, Street Department Other 1000-670-690-0000, Permissive Motor Vehicle License 2101-610-396-0000, and Stormwater 5704-800-399-0000. The Contingency Fund of Ashville 1000-930-930-5001 would be used as a reserve fund for 2101-610-396-0000.
