The Council of Ashville convened in Regular Session from 6:35 PM to 6:59 PM in the Council Meeting Room at 200 East Station Street, Ashville, Ohio 43103. Mayor Wise called the meeting to order with the Pledge of Allegiance and a moment of silence.

**MINUTES OF PREVIOUS MEETING:** Brad Lutz moved, seconded by Nelson Embrey, to approve the May 20, 2019 minutes as presented. All votes were yea, with the exception of Randy Loveless, who abstained.

**MAYOR'S REPORT:** Mayor Wise thanked everyone who participated in the clean-up day on June 1, stated that the car show held in the park the previous weekend was a good time, announced that the location for setting off the fireworks on the Fourth of July is still undecided, and reported that the auditors discovered an error with a couple of employees' payroll, and that it had been corrected by the clerk. Mayor Wise also reminded everyone that the first movie for Movies in the Park will be shown on Friday, June 14.

### DEPARTMENTAL REPORTS

**VILLAGE ADMINISTRATOR:** The VA reported that a Planning & Zoning meeting for the rezoning application for the property at 204 Long Street has been scheduled for June 11, that he is working on the ordinance for the sale of the abandoned alley to Dennis Ward, and that at the end of June, PICCA will begin a 10-week transportation program for the residents of Ashville and South Bloomfield. Nelson Embrey asked if that would become a regular thing, and the VA said at the moment, he was only aware of it being for 10 weeks.

### **FISCAL OFFICER:**

1. Brad Lutz moved, seconded by Randy Loveless, to approve the March 2019 Financial Report. All votes were yea.

### **VISITOR COMMENTS:**

1. Andrew Hite asked council when (or if) they were going to spray for mosquitoes. The VA advised that the village will not be spraying because studies have found that spraying isn't effective in rural areas surrounded by farms. The VA noted that the best defense against mosquitoes is preventing areas of pooling water. Hite also asked if there was anything that can be done to stop people speeding on Park Street. Council recommended calling the PD if speeding is witnessed.


### **COUNCIL COMMENTS:** None
