Hardbarger said the survey done by the Village is wrong and that his daughter has a survey proving it. Council asked Mr. Hardbarger to provide a copy of his daughter's survey for them to review and they would go from there.
- Robert Wilt of Kraft Drive said he appreciates that the Street Department attempted to fix the potholes with cold patch but it wasn't done well. Wilt asked when a permanent solution can be expected for the corner of his yard. Adam Kehoe said he will look at it that week.
