The Council of Ashville convened in Regular Session from 6:32 PM to 7:21 PM in the Council Meeting Room at 200 East Station Street, Ashville, Ohio 43103. Mayor Wise called the meeting to order with the Pledge of Allegiance and a moment of silence.

MINUTES OF PREVIOUS MEETING: Nelson Embrey moved, seconded by Roger Clark, to approve the December 20, 2021 minutes as presented. All votes were yea, with the exception of Matt Scholl and Steve Welsh, who abstained.

DEPARTMENTAL REPORTS

VILLAGE ADMINISTRATOR: Franklin Christman reviewed the evening's legislative items, reported that the Center Alley Outfall Project has been completed, and he will be submitting applications for LED lighting & RRFB at two intersections and LED lighting at three additional locations. Christman also stated that he had submitted two applications to American Rescue Plan Act (ARPA) Ohio Department of Development for the I & I Project for South Metershed and North Water Tower and is waiting for the agreement to be returned. Nelson Embrey asked why Christmas lights didn't go up this past Christmas. Christman explained that South Central Power changed their policy on using their poles and that the village wasn't notified until late October of the change which didn't allow the Men's Club time to comply with the new policy. Christman said that the Village had to take down all flags and banners due to the policy change. Christman said he is working on the application so that the flags and banners can go back up.

LEGISLATION

ORDINANCE(S) FOR FIRST READING

AN ORDINANCE TO ACCEPT THE CLIFTON BROTHERS LAND LLC, LANDOWNERS (HEREINAFTER REFERRED TO AS "LANDOWNER") AND LARRY & SCOTT WILLS (HEREINAFTER THE "DEVELOPER") APPLICATION FOR ANNEXATION BY THE LANDOWNER AND DEVELOPER, ET ALL FOR ANNEXATION OF CERTAIN TERRITORY CONTAINING 21.419 +/- ACRES IN THE HARRISON TOWNSHIP, COUNTY OF PICKAWAY, STATE OF OHIO TO THE VILLAGE OF ASHVILLE AND DECLARING AN EMERGENCY. Nelson Embrey moved, seconded by David Rainey, to have the First Reading. All votes were yea. Roger Clark pointed out that the description of the property to be annexed provided by the county commissioners listed two different property descriptions. Council instructed the VA to look into the issue and correct legislation as needed. Nelson Embrey moved, seconded by David Rainey, to approve the First Reading. All votes were yea, with the exception of Matt Scholl and Steve Welsh, who voted no.

AN ORDINANCE FOR THE REZONING OF ONE-HUNDRED-FORTY-SIX-POINT-ZERO-FOUR-TWO (+146.042) OF LAND OWNED BY BATES REAL ESTATE, LLC WITHIN THE VILLAGE OF ASHVILLE TO PLANNED UNIT DEVELOPMENT. Nelson Embrey moved, seconded by Roger Clark, to have the First Reading. All votes were yea, with the exception of Matt Scholl and Steve Welsh, who voted no. Steve Welsh said he has no problem with the annexation and rezoning but expressed concerns about the Village having the capacity to provide water service. After the reading, David Rainey moved, seconded by Nelson Embrey, to approve the First Reading. All votes were yea, with the exception of Steve Welsh and Matt Scholl, who voted no. Nelson Embrey asked to discuss the water issue before moving on. Embrey asked the VA if we are able to buy water elsewhere. Christman said we have a pending agreement with Earnhart Hill that will allow us to provide an additional 150K gallons of water and once the agreement is approved, the hook up process will take about six months. Nelson Embrey asked if buying water from South Bloomfield was an option. Jim Welsh said they do not have the capacity to supply us water on a continuous basis. Jim Welsh went on to say that the bigger concern with the connection to Earnhart Hill is that the EPA has to inspect the connection once it's completed and he can't estimate what their timeline is. Embrey requested a more defined timeline

as to when the Village will be able to provide water before approving. Steve Welsh reiterated the urgency of getting a committee together to begin working on getting a new water plant built. Mayor Wise asked Maronda Homes representative, Laura Comek, if she knew how many units they would be constructing a year once the development is approved. Comek said 45-50 single family homes but she wasn't clear on the multi-family units. Comek said she will get more definitive numbers on construction and capacity and report back to the Village.

HORTON AND DECLARING AN EMERGENCY. Nelson Embrey moved, seconded by David Rainey, to have the First Reading. All votes were yea. After the reading, Nelson Embrey moved, seconded by David Rainey, to accept the First Reading. All votes were yea, with the exception of Matt Scholl, who voted no.
