Re: Enterprise Zone (EZ) for Production Plus Notification Letter

Dear Mr. Wolfe:

The Village of Ashville is seeking to execute an Enterprise Zone Agreement. The agreement provides for a 75% property tax abatement for 10 years with Marais Capital LLC, in connection with the construction of a new manufacturing facility at 100 South Business Place, Ashville, OH 43103. A copy of the proposed agreement with additional details is attached, along with a map of the Ashville Enterprise Zone.

Ohio law encourages the involvement of the Board of Education in all local tax exemption program decision-making. You may wish to closely review Sections 5709.61, 5709.62, 5709.631, 5709.82, 5709.83, and 5709.85 of the Revised Code. Notice to the Board of Education on Enterprise Zone proposed agreements has been set at a minimum of fourteen (14) days prior to formal review and action by the local government. Pursuant to Section 5709.83(A), the Board of Education may offer comments on the proposed agreement or request a meeting for additional details.

Tim McGinnis is the Enterprise Zone Manager. Tim McGinnis can meet with the Board of Education at your convenience and explain and discuss the Ohio Enterprise Zone Program. - 6. Project Description: Production Plus is a manufacturing and fabrication company located in Ashville, Ohio in Pickaway County. The company employs a total of 13 individuals consisting of positions such as production, fabrication, welding, sales, marketing, and customer service. The company under new ownership since 2016 has returned to profitability in 2019, 2020, and 2021, with sustained revenue growth each year. With success in the marketplace the company plans to expand its operation by adding 25% to its employment base as well as investing \$1.3M in land and facilities resulting in an increase of 12,000 square feet to it production and office facilities. In addition to its employment and facilities expansion, the company plans to invest over \$100,000 in new machinery and equipment.




EXHIBIT A-1 to EZ AGREEMENT PRAIRIE ACRES/PRODUCTION PLUS SITE
