

## LEGAL NOTICE

Sealed proposals will be received by the Village of Ashville, Village of South Bloomfield, and Harrison Township, Pickaway County, Ohio until 12:00, noon, local time, Friday, September 25, 2009, for furnishing all the necessary material, labor, equipment, tools and services for the refuse, garbage, recycling collection, removal and disposal for said location hereafter defined as the service, all as set forth in the specifications now on file at each governmental office. This joint action is the result of action by the North Gate Alliance which was created from a Cooperative Economic Development Agreement (CEDA). Each listed governing entity endorsed this bid process and the bid specifications.

A pre-bid meeting will be held at the Ashville office, Tuesday, September 22 at 10:00 am, to answer all questions concerning "Specification".

For South Bloomfield the bids will be delivered to the office at 5023 South Union Street, South Bloomfield, Ohio 43103, and for the Village of Ashville and Harrison Township the bid will be delivered to the office at 200 East Station Street, Ashville, Ohio 43103, until 12:00, noon on September 25, 2009. At said offices, they will be publicly opened and read aloud at 12:01.

The service required is:

- (A) A bid for Residential Refuse Service.\*
- (B) A bid for Commercial Refuse and Special Events Refuse Service. \*

Proposal is required for each service the contractor will perform. All proposals shall be submitted to the above listed government entities and shall be sealed in an envelope and marked as follows:

- a. "Villages and Township-Residential/Commercial/Special Events Refuse, Garbage, and Recycling Collection, Removal and Disposal" Option One,
- b. "Villages and Township-Residential/Commercial/Special Events Refuse and Garbage Collection, Removal and Disposal" Option Two,

\* within the legal limits of the Village of Ashville, South Bloomfield, and Harrison Township.

Proposals are to be mailed in separate envelopes to the office addresses mentioned above, as to arrive before the above mentioned deadline. Any Bid Proposals received after the deadline will not be considered and will be returned to the bidder unopened.

The specifications may be obtained from Village of Ashville and Village of South Bloomfield at the address listed above during the hours of 9:00 A.M. to 3:00 P.M. Monday – Friday. Any contractor requesting the Bid Specifications be mailed shall provide the Villages or Township with a self-addressed stamped envelope. The Specifications can also be found on each Website [www.ashvilleohio.net/gov](http://www.ashvilleohio.net/gov) and [www.southbloomfield.org](http://www.southbloomfield.org), Click on REFUSE SPECIFICATIONS.

Each bidder is required to furnish with its Proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in bond form, shall be issued by a Surety Company or Corporation licensed with the State of Ohio to provide said surety.

Each bidder must insure that all employees and applicant for employment are not discriminated against because of race, color, religion, sex or national origin.

The Villages and Township jointly reserve the right to reject any and all proposals, and to award to the best bidder. Each proposal must contain the full name of every person or company interested in the same.
