The Mayor's Column - Railroad Crossing Relocation from Griggs to W. Station St.

I am pleased to announce that Ashville has been able to secure five different funding sources to relocate Griggs railroad crossing to West Station Street.

In the fall of 2009 discussion was initiated by Chief Dennis Palmentera, who how fast the trains were traveling through the village. After the Intermodal was opened they were traveling 60 mph and safety concerns were expressed. A meeting was held with some of the partners listed in the center column. Gates were discussed at Griggs. The gates would cost about \$300,000.

As pedestrians were monitored, it was noted that the majority were crossing at Station Street. It was observed that vehicles were traveling from Griggs to Station. The idea began to move the crossing.

The partners to this railroad crossing improvement project include:

- ♦ The Ohio Public Works Commission (OPWC), represented by, Linda Bailiff, Abbey DeHart, Michael Miller, and Susan Spiker.
- ♦ The Ohio Rail Development Commission (ORDC), represented by, Matthew Dietrich, Susan Kirkland, and Joe Reinhardt.
- ♦ The Public Utilities Commission of Ohio (PUCO), represented by, Leah Thomas Dalton and Jill
- ♦ Norfolk Southern, represented by, Bill Barringer, Casey Talbott, and Cayela Wimberly.
- ♦ Ashville represented by the Mayor, Village Council, Village Staff, and Christopher Tebbe.

Therefore, it was concluded that it made a great deal more sense to relocate the roadway and crossing

to where the majority of people were either walking or the ultimate destination of their vehicle. This will be done as two projects. The first project is the roadway improvement, and the second project will be the crossing and gates.

OPWC Grant \$317,813.00 OPWC Loan \$105,937.00

Project Two

PUCO \$70,000.00 Norfolk \$ 25,000.00 ORDC \$ 90,000.00 Total \$773,750.00

For residential refuse removal the monthly charge will not change. The additional 50¢ contracted rate increase is being absorbed into the current charge. The goal is to bring all users of refuse into an administrative fee of 5%. It use to be 10% for all users and we have been working to cut that in half. Maybe we can do more decreases next year.
