**Leaf Pick-up Ashville's Service Department**



The Village's Leaf pick-up service begins the first week of November. It is scheduled to continue through Monday, December 4<sup>th</sup>. The exact date is driven in large part by weather and the leaves on the ground. The next newsletter issue will talk about the village's work for snow and ice removal. This usually follows leaf pick-up but they may overlap. The same truck is used for both services. In the past the Service Department had a specific street schedule Monday through Friday. With the equipment we now have the entire village is checked each day. NOTE: To be removed leaves must be taken to the street. The day to day pick-up may be changed due to inclement weather or reasons beyond our control.

**WHAT TO AVOID>>>>>**

Leaves piled in front or back of vehicles will not be picked-up; we use the ten (10) "foot rule" to prevent damage. It is also helpful not to place leaves under low hanging tree limbs because of the height of our equipment. **No brush or flowers will be picked up. Local Waste Services on Monday's Collection Day will take limbs that are bundled or weeds (flowers) that are bagged. They will also take bagged leaves. You can also use the Gray Refuse Toter the was recently distributed.** The size of our equipment prevents us from traveling in alleys. **The Mayor's Column—New Council Member Brad Lutz**

Brad Lutz was sworn in as the Ashville Council member on September 25, 2017. He replaced Todd Henson who moved outside of Ashville. Mr. Lutz has been the Pickaway County Administrator for the last six years. He said his reasons for wanting to be a village council member comes from his parents. "My parents were the inspiration to do this," he said. "For both my sister and myself, they put a bug in our ear, if you will, to help become a part of your community. Whether that's public service as an elected official or joining your local band boosters organization, it's about being a part of the community. For me that took form in being a public official; for my sister that meant joining the army. These are the things that were instilled in us as core values." Mr. Lutz said he wants to spend some time learning before he begins looking at implementing any new ideas. "I think my number one goal is to learn from the current council

people what the direction of the village is in regards to strategic planning, capital needs and things that have been brought to them by the citizens that are important," he said. "I want to spend my first few months learning those things, because I feel we do have a really good council. I don't think there are any great deficiencies that I need to come in and feel I need to address. "Ultimately, when I've been here longer, I think we need to make sure we continue the projects we've started in the village—intersection improvements, connectivity, and those things will be very important," he said. "Infrastructure is something I have a passion for and believe as a growing community, it's important to stay ahead on. I know that will be an area of focus as we move forward. That's not to insinuate the village hasn't; we just need to continue to do it that way." Mr. Lutz said another inspiration for running

was his aunt and uncle, Fern and Taylor Lutz. "They are more or less lifelong residents of Ashville," he said. "They used to own businesses in town, work at the school and be a part of the village committees. Their work in this community is inspiring and that's what I aspire to be as a member of this community, someone who never stops working to make this a better place." The Village Council and Mayor look forward in working with Mr. Lutz.
