- 13. Time of completion for the project is 549 consecutive calendar days from Notice to Proceed for substantial completion and 610 consecutive calendar days from Notice to Proceed for final completion of contract work.
- 14. Liquidated Damages

i. Substantial Completion: \$1,000.00 per dayii. Final Completion: \$1,000.00 per day
