AN ORDINANCE AMENDING ORDINANCE 2014-04, 2015-04 AND 929.02 (96-13, 2006-06, 2009-03, 2010-07) FOR A DEBT SERVICE CHARGE FOR THE WASTEWATER PLANT EXPANSION PROJECT IN COMPLIANCE WITH OHIOEPA FINDINGS AND ORDERS FOR THE VILLAGE OF ASHVILLE, AND TO ALTER THE CHARGE FOR WASTEWATER IN THE VILLAGE OF ASHVILLE. THIS AMENDED ORDINANCE WILL NOT CONFLICT WITH THE OHIO REVISED CODE (ORC) LIMITATIONS AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Ashville, Ohio authorizes by ordinance the rates charged for the wastewater utility; and

WHEREAS, it becomes necessary on occasion to adjust those rates.

WHEREAS, this charge will for the collection of funds for the Wastewater Plant Expansion Land Acquisition, Planning, Design, EPA Application, and Construction.

NOW, AND HEREAFTER BE IT ORDAINED BY THE VILLAGE COUNCIL, VILLAGE OF ASHVILLE, PICKAWAY COUNTY, STATE OF OHIO THAT:

SECTION ONE

That the following rate structure will be added to Chapter 929.05 Sewer Rates:

SECTION TWO

The new charge in Section One is the result of a mandated OhioEPA Improvement at the Village of Ashville Wastewater Facility, see "Findings and Orders".

SECTION THREE

This Debt Proceeds increase will be based upon an Application to DEFA which included a PROJECTION SCHEDULE -Projection of Revenues and Expenses of the System. This will be communicated in the newsletter one month prior to implementation of increase.

SECTION FOUR

That the following rate structure will be used as a replacement for Chapter 929.02 Water:

- The 2016 rate of \$6.99 charge (rate) will be applied in thousand gallon increments to all quantities. a)
- The \$6.99 charge will be increased by a factor of 100% for all wastewater service outside Village which b) means wastewater service furnished to consumers outside the corporate limits of Ashville in accordance with authority for the service previously granted by the Council of this Village.
- SECTION FIVE

That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements, and shall go into full force and effect immediately upon its passage by Council.

David Rainey moved, seconded by Nelson Embrey, to have the First Reading. Nelson Embrey informed the residents that the gas aggregation was being reintroduced because residents may not have fully understood what the aggregation was and how it works. He emphasized that it's totally optional to enroll and residents can opt out at any time if they do enroll. Todd Henson asked the VA if we are obligated to use a certain broker. Christman said that we are able to choose our broker. After discussion, Nelson Embrey moved, seconded by Todd Henson, to accept the First Reading. All votes were yea.

Franklin Christman followed up Embrey's statement by noting that the Debt Service fees are a separate line item on the monthly utility bill to show that 100% of the fees are going to Debt Service. After discussion, Nelson Embrey moved, seconded by Brian Garvine, to accept the Third Reading and adopt as an emergency. All votes were yea, with the exception of Todd Henson who voted no. Motion passed.

CLERK/FISCAL OFFICER REPORT: David Rainey moved, seconded by Nelson Embrey, to approve the June 2016 Financial Report. All votes were yea.

1. Randy Loveless expressed his gratitude to the Ashville Police Department and thanked them for their service to the community. He also noted that the historic Ashville traffic light is going to be featured on the cover of Road and Track Magazine.

2. Brian Garvine stated that he had been contacted by a resident who had concerns with HOA as it relates to permits and other property issues in the Ashton Village Subdivision and surrounding subdivisions. Garvine asked for it to be discussed at next Committee of the Whole meeting.

3. Nelson Embrey noted an article that was published in The Columbus Dispatch that reported that the VA of Mt. Sterling was accused of stealing \$1,000,000 from the village over a period of four years. Embrey stated he was appalled and unsure of how this went undetected. Embrey assured Ashville residents that the village uses software provided by the State of Ohio Auditor's Office, which is designed to prevent misuse of funds. He also explained that the village has implemented internal controls that prevent one person from handling monetary and financial transactions exclusively. All transactions require the signatures of at least two employees. Embrey wrapped up by requesting a 2nd Quarter Audit of the financial records on Monday, August 8 at 6:00.

4. David Rainey also thanked the Ashville PD and village staff. Rainey reminded the residents of the upcoming Gazebo Gatherings and invited all to attend. He noted that he really likes the banners that have been hung around town representing the Gazebo Gatherings. Rainey rounded off his comments by thanking the Haddoxes for working with the village on easement issues at their property.





Regarding: Debt Service Charge for Water Resources Recovery Facility Dear Neighbor:

In 2009, the Village of Ashville began a process to investigate the current wastewater facility. The purpose of this analysis was to determine the village's current and future need. The following occurred:

- August 2011 URS was selected from a field of 12 engineering firms to do that investigation
- April 2012 URS submitted their Report.

While the above process was taking place the OhioEPA instituted "Findings and Orders" These "Findings and Orders" indicate that the Village of Ashville will have to replace the facility or face substantial financial penalties. While we were working on the question of our wastewater facility, the OhioEPA removed the option to "Do Nothing".

- August 2012 it was decided from the report and the OhioEPA Findings and Orders to build a new plant in a different location.
- Village of Ashville obtaining a design and acquisition loan from Ohio Water Development Authority (OWDA) for 1.1 million dollars. At the time a "Debt Service Charge" was put in place for 69¢ per thousand gallons of water to repay that loan.
- July 2014 an agreement to purchase land was completed
- March 2015 a Permit to Install (PTI) and other permits were submitted to the OhioEPA. We are now at the construction phase of the facility.

The Planning and Design by AECOM, formally URS, indicated a total price for the Water Resource Recovery Facility is estimated to be 13.4 million dollars. This price may be reduced by the actual construction cost. The Village of Ashville needs to adjust the 69¢ charge. The sooner this takes place the less future adjustment will be necessary. Therefore, the enclosed Ordinance 2015-04 is before to Village Council. The charge will be adjusted to a rate of \$1.29 or a 60¢ increase.

Just to be clear, this will not be the last increase for the facility. The intent is to spread these increases over time. In 2009, Village Council passed an Ordinance that would allow for a method to keep the cost of operating utilities in line with the fees associated with that utility. Ordinance 2009-03 indicates that after December, the Consumer Price Index (CPI) will be used to determine what is needed to maintain a rate schedule consistent with costs. That percentage is indicated to the right. The current percentage is 8% and will 1% be reflected in the next


Debt Service and Infiltration & Inflow (I & I)
