- 5. Estimated Construction Cost Savings: \$800,000




Administration Building Revisions

- Reduced size of building from ~3200 sq. ft. to ~1600 sq. ft.
- Building construction to be timber framed with metal siding and roofing.
- Building has the following facilities:
 - Office
 - Meeting/Break Room
 - Laboratory
 - Unisex Bathroom
 - Storage Area
 - Mechanical Room

 - 30 Years, 1.4% plus or minus
 - Nutrient Reduction Addendum-Applied for \$3.0 million, 0% loan
- Ohio Public Works Commission
 - Loan Assistance Grant-2016, Application being prepared
 - OPWC Grant and 0% Loan-Application to be submitted 10/2/15.
 - OPWC Application Amount: \$500k Grant, \$500k 0% loan.

 - Request Construction Loan: December 1, 2015 (January 1, 2016)
 - Notice to Proceed: January 2016 (TBD) (or Feb. 2016)
 - Construction Duration: 20 Months

 - Finalize Easement Issue: December 30, 2015
 - Advertisement for Bids: January, 2016
 - Open Bids: February, 2016
 - Submit Bids to DEFA: February, 2016
 - Sign Loan Docs: March, 2016

 - Notice to Proceed: April/May 2016 (TBD)
 - Construction Duration: 8-10 Months
