Franklin Street, Circleville, Ohio 43113 weekdays from 8:00a.m. to 4:00p.m. or at Ashville Vi llage Hall at 200 East Station Street, Ashville, Ohio 43103. Proposals must be submitted on the forms supplied and according to the instructions with the Bid Package. There is a \$20 non-refundable plans fee. Each proposal shall be accompanied by a bid guaranty. The bidder may supply for the bid guaranty a Bid Guaranty and Contract Bond for One Hundred Percent (100%) of the total amount of the bid; or the bidder may supply a Certified Check, a Cashiers Check, or an irrevocable Letter of Credit to Ten percent (10%) of the total amount of the bid. The date set for completion of this project is September 30, 2015. The minimum wage to be paid shall be in accordance with the Federal Davis-Bacon Wage Rates established for Pickaway County. This project is funded in part with federal Community Development Block Grant (CDBG) funds and therefore is subject to CDBG regulations. Preference on this contract will be given to Ohio products, materials, services and labor. The estimated cost of the contracted work is \$72,000.
